ARTICLE XVI - Miscellaneous Laws

(XVI-810

ANY officers once removed from office for just and stated cause may not hold said office again.)
Approved last meeting

XVI-820

ALL REQUISITE OFFICERS SHALL REPORT AS REQUIRED TO THEIR KINGDOM SUPERIORS. THEY SHALL ALSO COPY ONE ANOTHER ON THEIR REPORTS. COPIES MUST ALSO BE PROVIDED TO THE TERRITORIAL BARON AND/OR BARONESS WHERE APPLICABLE. FAILURE TO DO SO CAN BE HELD TO SERVE AS A RESIGNATION FROM OFFICE BY THE GREAT OFFICER OF STATE TO WHOM THAT OFFICE REPORTS. RESIGNATION FROM OFFICE IS WITHOUT PREJUDICE.

XVI-830

FAILURE BY REQUISITE OFFICERS OF A BRANCH TO SUBMIT A DOMESDAY BY ESTABLISHED DEADLINES WILL BE CAUSE FOR AN *AUTOMATIC* SUSPENSION OF SAID BRANCH AND HELD TO SERVE AS AN *AUTOMATIC* RESIGNATION OF SAID OFFICER(S), PENDING INVESTIGATION BY THAT OFFICE'S KINGDOM SUPERIOR. SAID KINGDOM SUPERIOR(S) MUST MAKE REASONABLE EFFORTS TO NOTIFY SAID OFFICER(S), FELLOW OFFICERS AND/OR TERRITORIAL BARON AND/OR BARONESS, IF APPROPRIATE, OF SAID SUSPENSION BEFORE PUBLISHING IT.

Addendum 2

Proposed Modification to Kingdom Law XVI-200

Current version:

The research and display of medieval gunnery is to be permitted, but no weapon is to be discharged under any circumstances under SCA auspices, except for signaling purposes at the Pennsic War.

12/1/02 Pieter's version (incorporating several other comments):

The research and display of medieval gunnery is to be permitted, but no weapon is to be loaded and/or discharged under any circumstances under SCA auspices, except for signaling purposes at the Pennsic War. Exceptions can be granted by the Kingdom Seneschal on a case-by-case basis for classes and demonstrations conducted by recognized experts in the field of black powder gunnery.

12/13/02 Tarrach's version:

The research and display of medieval gunnery is to be permitted, but no weapon is to be loaded or discharged under any circumstances under SCA auspices, except for signaling purposes at the Pennsic War, or for classes and demonstrations conducted and certified by special experts in the field of black powder gunnery. Signing of additional waivers noting specific risks of blackpowder gunnery for participants and spectators will be required. Certification requires a majority vote by a group of no less than 3 special experts. Special experts will be chosen by peer review and warranted by the Crown.

If I may give some advice here you might want to define what an expert is and how you become an expert does 4 year in the army ordinance make me an expert. It sounds like it might I was trained to blow up lots of things

12/12/02 Greeting to the Curia from Alexandra,

I checked with Corpora and it doesn' t address firearms (cannons). Unless a Society Officer says otherwise changing this wouldn' t be an issue. I would suggest that it be the Earl Marshal instead of the Seneschal. To me a weapon is a marshal thing. Are there warrants for the folks who are doing this now? As far as the wording I agree with Midair to have "loading and/or discharging"
